4. Public Comment:

Commission heard public comment on the need for cooling centers, communications with County Human Services Director Ellen Timberlake, available farmers market vouchers for seniors, an update on the Senior Community Service Employment Program (SCSEP) wait list, an introduction to the Lifelong Learners of UCSC group, and a Metro update.

5. Senior Legislature Report

Staff shared a redlined version of AB797 and provided an update from Molnar indicating that the bill is no longer supported by CSL because of significant changes made by the Assemblymember.

6. <u>New Business/Action Items</u>

6.1. Watsonville Senior Center Funding

Rivas reported that the Watsonville City Council defunded the Watsonville Senior Center, while continuing to fund programs that operate from the facility. Although the facility is within the city limits, many of the service recipients live in the County.

Authorize Commission Officers to draft a letter to the Board of Supervisors in support of funding all senior centers in Santa Cruz County

6.2. Joint Retreat Next Steps

Sones reported that the Volunteer Center received State grant funding for emergency preparedness response training. The IHSS Advisory Commission will lead follow-up efforts for the Joint Retreat scarcity of providers issue. Retreat next steps will be on the August agenda.

7. Strategic Action Plan Reports

<u>Elected Official Outreach</u>: Tuosto interviewed John Laird on Community TV. Commission reviewed the Board response to their advocacy letter for cost of living increases in CORE funding contracts. Several Commissioners had informal contact with their District Supervisors.

<u>Community Outreach</u>: Fohrman is auditing resource contact information in the *Seniors Resource Directory*. Commission discussed the You Are Not Alone (YANA) program. Kempf reported that AAA provides training for outreach phone calls to seniors experiencing social isolation. AAA will give the following presentations: AARP Age-Friendly Designation Efforts (August), AAA Duties and Programs (October), NPO Wage Inequities (December) and 2019 Needs Assessment Results (February).

<u>Senior Housing</u>: Tuosto reported that he is researching the impact of developer buyouts on County affordable housing stock and will advocate to the Planning Commission on behalf of seniors.

<u>Transportation</u>: Lewis did not attend the last E&D TAC Advisory Committee meeting but continues to monitor and report sidewalk safety issues. Lewis discouraged the use of scooters as an affordable transportation option.

<u>Media Outreach</u>: Media announcements are ongoing. Lewis reported that Commission contact information is out of date on the County webpage.

<u>Public Guardian</u>: Commission reviewed the April 16th Board of Supervisors agenda item approving a five-position staffing expansion for the Public Guardian's office, and County Health Services' Operational Plan Objective #79 which targets an increase of four new Public Guardian probate referrals per month by June 2021.

3. Public Comment:

- 3.1. Daugherty reported on SCMTD's fixed-route bus driver shortage, text alert service for route cancelations, proposed fare waivers for riders with vision impairment, and Daugherty's commendation for 30 years of service.
- 3.2. Talbot announced the Area Agency on Aging senior (over sixty) bilingual survey online and in hard copy. It is conducted every four years and addresses a variety of issues impacting seniors.
- 4. Senior Legislature Report: No Report
- 5. AARP Age-Friendly City Designation

Kempf gave an overview of Santa Cruz County's efforts to achieve AARP Age-Friendly designation. AARP monitors 8 domains impacting quality of life for seniors and assigns a livability score. The County Board of Supervisors recently voted to adopt the Seniors Council's proposed plan to become an Age-Friendly Community. Santa Cruz, Scotts Valley and Watsonville cities will meet to discuss next steps. A County-wide working group will decide on domains, although cities can further customize with activities that better meet their needs. 
