1. Call to Order/Roll Call/Agenda Review

Meeting convened at 12:33 PM.

Commission welcomed new 1stDistrict Commissioner, Suzanne Doty.

2. Motion to Approve October 18, 2022 Meeting Minutes

Motion to approve minutes. Motion/Second: Taylor/Sones **Motion passed unanimously.**

3. Public Comment: None

4. New Business/Action Items:

4.1. San Lorenzo Valley (SLV) Senior Center Update

Raner-Walter updated the Commission on recent developments at the SLV Center Senior Center. The center provides a variety of resources and courses including exercise, dance, art, and multigenerational activities. The County Board of Supervisors cut CORE funding for the center in June 2022, so the center is now funded entirely by grants and donations. Meal on Wheels serves lunch at the center, provides transportation, schedules speakers including the District Attorney's office to speak on scams impacting seniors. Other District 5 senior resources include the Mountain Community Resource Center, Valley Churches United, and the Scotts Valley Senior Center. Rivas emphasized the importance of multi-generational programming.

4.2. Assembly Bill 361 Statement of Findings

Commission considered whether to authorize meeting remotely under the provisions of AB 361 at the next meeting.

Motion to approve statement of findings authorizing the Commission to hold their next meeting remotely under the provisions of AB 361.

Motion/Second: Doty/Taylor **Motion passed unanimously.**

5. District Reports:

5.1. District 1:

Taylor is working on an article for the Retired Public Servants Association highlighting the importance of senior volunteerism. encouraged the Commission to collaborate with the Mid-County Senior Center to raise of the Commission as a platform to bring awareness to issues impacting seniors. Doty shared information regarding amendments to Santa Cruz County Code Chapter 13.32 clarifying language on rent control provisions for mobile home parks. Senior mobile home parks make up a substantial portion of available affordable housing units for seniors in Santa Cruz County.

5.2. District 2:

Rivas advocated for the Live Oak Senior Center at a recent Board of Supervisors meeting and the Live Oak School Board meeting. Bulldozing was postponed until June next year to allow for further negotiations. Meals on Wheels was given a six-month extension on their eviction notice. Watsonville Senior Center is doing well under their new director's leadership. Watsonville City Council created an advisory committee of community residents to receive feedback from residents on the center's resources and programs. Johannessen reported that County HSD t has published a Master Plan for Aging Request for Qualifications (RFQ) for a vendor to conduct the community needs assessment. The ratings panel is reviewing, evaluating and rating vendor proposals with vendor notifications scheduled for February.

5.3. District 3:

Sones reported that Elderday has paused in-center services because of a recent COVID-19 outbreak. They hope to restart in-center services by early January. Brennan had no report.

5.4. District 4:

Fohrman reported that District 4 has experienced an increase in vandalism and mail theft in low-income senior housing as well as an uptick in telephone scams targeting seniors. Staff will contact the District Attorney's to see if they can update the Commission on current scams.

5.5. District 5:

McKibbin reported being happy to be back after recent health concerns precluded her attending for several months. She reported receiving a great deal of support from the SLV senior center during that time. Childers reported very low temperatures in District 5 resulting in increased heating costs. Meals on Wheels staff increased in SLV, but many seniors live in homes less than ideal for aging in place.

7. Staff Report:

County Employee Diversity, Equity, and Inclusion Survey results were presented to the Data Equity Committee who provided excellent feedback. The County's Equal Employment Opportunity and Cultural Competence Plan was accepted and adopted by the Board at the December 13th meeting. Sheriff's office retracted their arrangement allowing the Commission to book full year in advance so in-person meeting will continue to be held at the United Way.

Meeting adjourned at 1:53 PM.
